**FISHING PERMIT RULES AND REGULATIONS**

Failure to comply with any portion of this permit shall be grounds for termination of the event at any time prior to or during the event. The Department reserves the right to establish reasonable time, date, and/or place conditions for each permit. Additional conditions as indicated:

- 1. Applicant shall provide, prior to issuance of permit, a Certificate of Insurance validating insurance in force meeting the following minimums, If applicable:
  - Comprehensive General Liability: Bodily injury liability insurance shall have limits of \$500,000 per occurrence. Property damage liability insurance shall have limits of \$100,000 per occurrence.
  - Professional liability: \$1,000,000 errors and omissions per occurrence.
  - Automobile liability: Bodily injury and property damage insurance shall have limits of \$500,000 combined single limits.
- 2. Applicant shall provide supervisory personnel as follows: \_\_\_\_\_
- 3. Applicant shall require participants to conform to the following safety measures: \_\_\_\_\_
