Pursuant to Section 110.6 of the Virginia Uniform Statewide Building Code a permit may be revoked if the work is suspended or abandoned, with no activity for a period of 6 months or more. A permit may be renewed to extend the time-frame for completion; renewal is at the discretion of the Building Official, but permits will typically be extended unless there are extensive continuous delays or other unique circumstances. It is in the applicant's best interest to renew a permit so that work started can be finished under the original permit and the building code requirements in place at the time the permit was first issued.

FEE SCHEDULE FOR RENEWALS

1 st Renewal within 6 month time frame (30 day grace period)	No Charge
1 st Renewal more than 30 days overdue	\$49.50 renewal fee (Includes technology fee)
Subsequent Renewal	\$49.50 renewal fee per 6 months elapsed (Includes technology fee)
Additional Site Visit Fee required if last inspection is over 1 year ago or Building Official discretion	\$82.50 site visit (Includes technology fee)
Exceptions:	
<ul style="list-style-type: none"> If calculated fee is > original Building fee then the renewal fee equals the original Building fee or \$200, whichever is less "Original Building fee" does NOT include trade permit fees or plan review fees. Renewal of a trade only permit will be \$49.50 for any expiration except the free 1st Renewal noted above. 	
<u>Zoning Permit</u>	
The Zoning Permit is valid so long as the Building permit remains valid. Therefore, any renewal occurring within the 6 months + 30 day grace period does not require a corresponding Zoning Permit renewal. If a Building Permit lapses for over 30 days, and a Zoning Permit was required originally, a new (renewed Zoning) permit is also required, with a \$110.00 fee (Include technology fee).
